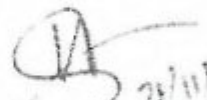

Eligibility: Valid PAN, GST, P. Tax receipt and Trade License to be submitted.

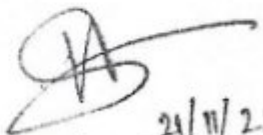
Reserved Price: The highest bidder will be selected on the basis of the reserved price fixed by the competent authority not on the basis of starting Price.
